The following are the Regulations for admission into MBBS/BDS Courses in all Medical and Dental Colleges affiliated to KNRUHS for the academic year 2026-27 under Management Quota in Private Un-aided Non-Minority / Minority Medical Colleges and Private Non-Minority Dental Colleges and Army College of Dental Sciences, Secunderabad and Neelima Institute of Medical Sciences (Affiliated to Anurag University).

NUMBER OF SEATS UNDER MANAGEMENT QUOTA:

The number of MBBS & BDS seats under Management Quota for the AY 2026-27 in Un-aided Private Non-Minority & Minority Medical Colleges, Un-aided Private Non-Minority Dental Colleges, Army College of Dental Sciences, Secunderabad and Neelima Institute of Medical Sciences (Anurag University) will be as permitted by NMC/NDC and shall be notified before counselling.

The tuition fee for the academic year 2026–27 is as per G.O.Ms.No. 98, Health, Medical & Family Welfare (C1) Dept., Dated: 07.08.2026.

The seat matrix for Management Quota seats for the AY 2026-27 will be displayed in the university website before exercising web-options for counselling.

In case of new MBBS/BDS seats permitted by NMC/NDC in the Medical & Dental Colleges affiliated to KNRUHS for the AY 2026-27, shall be added in the subsequent phases of counselling.

EDUCATIONAL QUALIFICATION:

In accordance with NMC Regulations,

the candidate should have passed Intermediate (10+2 pattern) or its equivalent examination with Physics, Chemistry, Biology (Botany, Zoology) / Biotechnology and English.

- OC/EWS candidates should obtain not less than 50% marks in science subjects.
 - BC/SC/ST candidates should obtain not less than 40% marks in science subjects.
 - OC/EWS PWD candidates should obtain not less than 45% marks in science subjects.
- The Candidate should have qualified in NEET UG 2026 as per cut-off scores notified below.

AGE:

The candidate should have completed 17 years of age as on 31-12-2026. The candidates who do not complete 17 years as on 31-12-2026 need not apply for the counselling. The above age criteria are applicable to all candidates of all categories.

CUT-OFF SCORE IN NEET UG 2026

Candidates should have secured the following cut-off score or above in NEET UG 2026 Examination.

ELIGIBILITY:

The candidates, who have qualified in NEET UG 2026 by securing cut-off marks or above have to apply for determining the State Merit position for Management Quota seats subject to the conditions specified in admission Regulations/Prospectus for the AY 2026-27.

A candidate for admission into Under graduate courses in Telangana should be Indian Nationals, Person of Indian Origin (PIO) or Overseas Citizen of India (OCI) card holders (PIO/OCI status issued before 04-03-2021) and shall fulfil the following provisions in G.O.Ms.No. 33, Health, Medical and Family Welfare (C1) Department, Date: 19.07.2024 and G.O.Ms.No. 150, Health, Medical and Family Welfare (C1) Department, Date: 08.09.2025. **(G.O. 33 & 150 is applicable to 85% of seats under Management Quota – B category).**

- (i) If the candidate has studied in an Educational Institution in such local area for a period of not less than 4 consecutive academic years ending with the academic year in which he appeared or as the case may be first appeared in relevant qualifying examination.

or

- (ii) Where during the whole or any part of the four consecutive academic years ending with the academic year in which he appeared or as the case may be, first appeared for the relevant qualifying examination, he has not studied in Educational Institutions, if he has resided in that local area for a period of not less than four years immediately preceding the date of commencement of the relevant qualifying examination which he appeared or as the case may be first appeared.

(iii) Local area herein means the State of Telangana. Further, in case the candidate has not studied in any educational institution and has resided in the local area as stated at (ii) above, to be eligible for admission into Under graduate courses under Competent Authority Quota, the candidate should have appeared for the relevant qualifying examination in the State of Telangana.

I. Provided that a candidate who studies outside Telangana for any period during the requisite four consecutive academic years ending with the academic year in which he appeared, or as the case may be, first appeared in the relevant qualifying examination, will be eligible to be considered if they fall under any of the below categories:

1. Children of employees of the Telangana State Government who have served or are serving outside Telangana corresponding to the candidate's year/s of study outside Telangana.
2. Children of serving or retired officers belonging to the Telangana cadre of All India Services (IAS/IFS/IPS) who have served or are serving outside Telangana corresponding to the candidate's year/s of study outside Telangana.
3. Children of defence personnel/ex-servicemen/Central Armed Police Force service who, at the time of joining service, have declared their hometown to be in the State of Telangana and who have served or are serving outside Telangana corresponding to the candidate's year/s of study outside Telangana.
4. Children of employees of a Corporation/Agency/Instrumentality under Government of Telangana, liable to be transferred anywhere in India as per the terms and conditions of his/her employment, who have served or are serving outside Telangana corresponding to the candidate's year/s of study outside Telangana.

II. Subject to the candidate submitting certificate of employment from the competent authority for the candidate's father/mother's service outside the State for the period corresponding to the candidate's year/s of study outside Telangana.

➤ Candidates are advised to carefully read the Prospectus, University Regulations, relevant Government Orders (G.Os.), and the eligibility conditions prescribed in this notification before proceeding with the payment of the Registration and Processing Fee. **The Registration and Processing Fee is non-refundable under any circumstances.** Therefore, candidates should ensure that they fulfil all eligibility criteria before making the payment, uploading relevant documents and submitting the online application.

85% of seats under Management Quota – B category in MBBS & BDS courses in to Medical and Dental Colleges affiliated to KNRUHS are reserved for Local candidates from the State of Telangana in accordance with G.O.Ms.No. 130, Health, Medical and Family Welfare (C1) Department, Dated: 27.09.2022. The remaining 15% of seats are open to the candidates from all over the country including local candidates by merit.

25% of seats under Management Quota – B category at Neelima Institute of Medical Sciences is reserved for local candidates from the State of Telangana in accordance with G.O.Ms.No. 40, Higher Education (UE) Department, Dated: 20.06.2023.

Candidates from all over the country are eligible for admission into Management Quota – C/NRI quota seats in to MBBS & BDS courses.

Foreign Students/NRI candidates are eligible for admission into MBBS and BDS courses under Management Quota – C/NRI quota seats. **Candidates should specifically put the option for NRI category in the online application to be considered for Cat C/NRI quota seats failing which such candidates shall not be considered for admission into MBBS and BDS courses under C/NRI category.**

There is separate registration for Competent Authority Quota and Management Quota. Candidates who have already applied for Competent Authority Quota Seats in response to this University earlier notification are also eligible to apply for the Management Quota seats.

SCHEDULE FOR REGISTRATION THROUGH ONLINE AND UPLOADING OF ALL RELEVANT CERTIFICATES:

Candidates can register online and upload scanned original certificates on the website <https://tspvtmedadm.tsche.in> from **06.00 AM on 13.08.2026** up to **06.00 PM on 20.08.2026**.

Provisional Merit position of the registered candidates will be prepared based on the NEET UG 2026 rank and other eligibility criteria notified, after verification of scanned original certificates. Final verification of original certificates will be conducted at the time of admission at allotted college by the admission committee of the college.

REGISTRATION AND PROCESSING FEE:

- Candidates are advised to carefully read the Prospectus, University Regulations, relevant Government Orders (G.Os.), and the eligibility conditions prescribed in this notification before proceeding with the payment of the Registration and Processing Fee. **The Registration and Processing Fee is non-refundable under any circumstances.** Therefore, candidates should ensure that they fulfil all eligibility criteria before making the payment, uploading relevant documents and submitting the online application.
- The Registration and Processing fee of **Rs. 12,000/- (Rupees Twelve Thousand only)** (Bank transaction charges extra) shall be paid online.

*Fee shall be paid online through Debit Card/Credit Card or Net Banking.

NOTE: Registration & Processing fee once paid will not be refunded or adjusted to a further date.

- In case of payment failure resulting in a subsequent successful payment (double payment), candidates shall submit their representation for refund of the failed/duplicate payment only through e-mail to **knruhs.doublepayments@gmail.com**. Upon verification, the amount received through the failed/duplicate transaction, if any, shall be refunded to the candidate's bank account by following due procedure only after the closure of admissions.

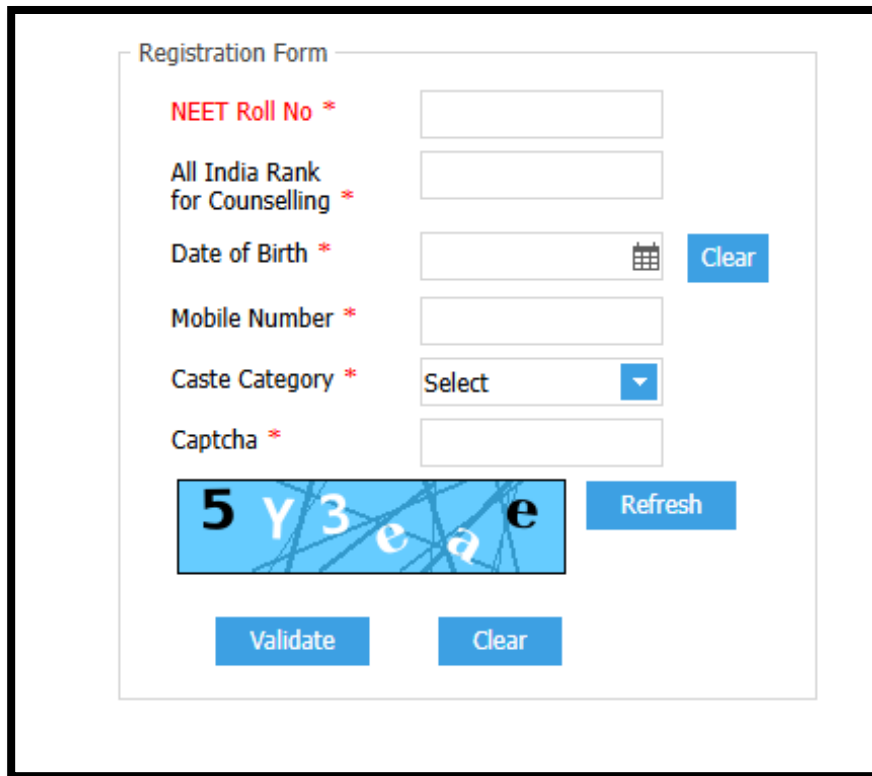

- Provisional merit list will be displayed on KNRUHS website after scrutiny of uploaded certificates and application. Verification of uploaded certificates will be done only once for web-based counselling irrespective of number of phases of counsellings. Hence, candidates who have applied online are advised to upload all original certificates at the time of online registrations without fail for scrutiny by concerned departmental officials. No individual communications will be sent. The notification for schedule for exercising web options will be issued separately on KNRUHS website. Candidates are informed to check the website regularly for notifications.
- Admissions will be in accordance with the procedure notified in Rules of Admission vide G.O.Ms.No. 114, Health, Medical and Family Welfare (C1) Department, Dated. 05.07.2017, subsequent amendments, G.O. Ms. No. 125, Health, Medical and Family Welfare (C1) Department Dated.22.09.2022, G.O. Ms. No 75, Health, Medical and Family Welfare (C1) Department Dated.04.07.2023, G.O. Ms No.33, Health, Medical and Family Welfare (C1) Department Dated:19.07.2024, G.O. Ms No.150, Health, Medical and Family Welfare (C1) Department Dated:08.09.2025 and relevant Hon'ble Supreme Court/High Court orders.
- Candidates have to exercise web options for seats in the interested colleges for MBBS course and BDS course separately. Candidates and parents are informed to exercise web options very carefully in order of their preference for colleges and also to take a print out of exercised web options which are uploaded for reference.
- The Admission Committee shall have power to review the admission in case of any errors, misrepresentation and can cancel the admission. In all matters relating to admissions, the decision of the Admission Committee shall be final and binding on the candidates and admissions cannot be questioned after closure of admissions.

ADMISSION RULES:

- The provisional allotment order of the candidate can be downloaded from website after payment of University fee by payment gateway. The candidate should submit the printout of the filled in Online application form, allotment order and original certificates along with one set of self-attested copies to the Principal of allotted college at the time of joining for final verification by the admission committee constituted at concerned college. The admission committee is responsible for scrutiny of the original certificates submitted by the candidate. In case of any discrepancy, the provisional allotment order for admission will be cancelled.
- Selected candidates have to join the college within the specified date by submitting all Original Certificates, Bonds, and pay the tuition fee as notified by the Government to complete the process of admission. If the candidate does not report at the allotted college within the specified time and complete the process as described above, the admission will be automatically cancelled.

- Selected candidates have to submit an undertaking in the form of notarised Affidavit on Non-Judicial Stamp paper, duly signed by the candidate and parent/guardian, stating that all the certificates including the caste and category certificates are genuine and they are responsible for any further consequences as per law shall be submitted at the time admission. If any discrepancy is noticed, the admission will be cancelled.
- Selected candidates have to submit Discontinuation bond for an amount of **Rs. 20,00,000/- (Rupees Twenty Lakhs only)** and Anti-Drug undertaking in the form of notarised affidavit, duly signed by the candidate, parent/guardian and witnesses (for discontinuation bond).

TUITION FEE:

The tuition fee for the academic year 2026–27 is as per G.O.Ms.No. 98, Health, Medical & Family Welfare (C1) Dept., Dated: 07.08.2026.

Note: The candidates selected against Management Quota Category-B & C (NRI Quota) Seats shall pay the Tuition fee as notified for Management Quota seat on the day of reporting in the form of Demand Draft in the name of the Principal of the respective college on the day of admission to the college. If the candidate fails to pay the tuition fee within the specified time of joining, the admission will be cancelled automatically.

DISCONTINUATION FEE:

Candidates cannot discontinue from the course after notified cut-off date for discontinuation or later. Candidates shall have to submit a bond for an amount of **Rs. 20,00,000/- (Rupees Twenty Lakhs only)** for the same on 100 rupees Non-Judicial Stamp paper, duly signed by the candidate and the parent/guardian. (Proforma is annexed).

SANCTION OF LEAVE BEYOND 3 MONTHS AND TERMINATION OF STUDENTSHIP:

- Every candidate after his/her admission shall attend classes on all working days (Theory, Practicals, Clinicals). If a student absents continuously for a period of 91 days or more and seeks permission to attend the course before 2 years after discontinuation, the candidate's application in the prescribed proforma shall be forwarded to the

Registrar with the recommendations of the Principal with requisite fees. If the Vice Chancellor is satisfied with the reasons for absence, the candidate may be granted leave of absence and permitted for Re-admission in such conditions as deemed necessary. Candidates who are absent for a continuous period of more than 2 years shall be deemed to have forfeited the admission into the course and the studentship shall stand cancelled without any further notice.

- If the break of study (91 days are more) in more than one spell, the candidate's representation in the prescribed proforma shall be forwarded to Government for appropriate decision in the matter with the specific recommendations of the Executive Council of the University.
- Candidates who are absent for cumulative period of more than (2) years, shall be deemed to have forfeited the admission in to the course and the studentship stands cancel without any further notice.
- The candidate has to pass the final examination for award of Degree for the course within double the duration of study period for the course or within the maximum period permitted by the National Medical Commission from time to time.
- On Re-admission the study period for the course shall be extended equivalent to the period of absence and the candidate shall be eligible to appear for final examination after completion of the extended study period for the course.

COLLEGE REGULATIONS:

Candidates are required to follow the rules and regulations of the college and should also abide by the regulations of the University. Candidates are informed that their correspondence with the university shall be forwarded by the Principal of college with his remarks (through proper channel) for consideration. Under no circumstances they should have any correspondence with higher authorities directly without prior permission of the Principal.

CLOSURE OF ADMISSIONS:

The closure of admissions is as per the schedule notified by the University in accordance with the schedule issued by Medical Counselling Committee/National Medical Commission/National Dental Commission.

COMMENCEMENT OF THE COURSE:

The course shall commence as per the schedule notified by National Medical Commission/Dental Council of India/Medical Counselling Committee. The duration of the course shall be calculated from the date of commencement of the course and shall be uniform for all the candidates irrespective of individual dates of admission.

POWERS OF THE PRINCIPALS:

Not with standing anything contained in these regulations, the Principals of Medical Colleges in the State may at any time before completion of the Under Graduate course either on his own motion or on the application of any person after due and proper enquiry and after giving the person two weeks time from the date of the receipt of the show cause notice to submit a written explanation and or on a personal hearing, order the cancellation of admission to the course, if in his opinion, such candidate had furnished incorrect particulars or false information in the application form or in the documents attached thereto or in the Statements made either before the authority In-charge of admissions or the Principal or any other manner. Against any such order of the Principal, an appeal shall lie to the Registrar, KNR University of Health Sciences, Telangana.

POWERS OF THE UNIVERSITY:

KNR University of Health Sciences, may either suomoto or on an application made to them, call for and examine the records relating to any selection or admission or cancellation thereof in respect of the admission made by the concerned authority, for the purpose of satisfying themselves as to the correctness of legality or propriety of such selection or cancellation and pass such order in relation there to as they deem fit including cancellation of the selection already published or admission already made, provided that the University may, before cancelling such selection or admission, give an opportunity to the authority and to the person affected to show cause against such cancellation. University has every right to cancel the admission of any candidate without any notice, if the certificates produced by the candidate are found to be fake /false/forged.

DISCIPLINE:

The students shall maintain strict discipline during the period of study/training program. The candidates shall not resort to any strikes during the period of their study. The students are not permitted in criticizing the policies of the Institute/University/Government either before the print or electronic media. Their grievances (if any) may be submitted to the Dean/Principal through proper channel. They are not permitted to approach the legal authorities/ NMC/Govt. without prior permission by the Institution and University. In case of violation of the conduct rules, the admission of the candidate is liable for cancellation apart from invoking the terms and conditions of the bond.

RAGGING:

Ragging is prohibited in the Educational Institutions of State of Telangana and students shall not involve in ragging which may lead to serious consequences including cancellation of seat and punishments as per law.

ANTI RAGGING ACT:
